

## **Stay & Play Golf Giveaway Contest Rules**

The contest will open on Friday, July 19, 2024 at 12:01 a.m. Atlantic Standard Time and will be active until Friday, August 2, 2024 at 11:59 p.m. Atlantic Standard Time.

### **HOW TO ENTER**

All eligible contestants can enter by registering as an active participant on the Fox Harb'r Resort promotional email list at the time of the draw or use the alternative method of entry below. No purchase is necessary to become an active participant on the Fox Harb'r Resort promotional email list.
